The Clerk circulated an annual report to the meeting summarising the activities of the Parish Council for the past year.

He then provided the meeting with an update regarding the proposals to install CCTV on the Main Street; an update of the costs to the Council of acts of vandalism and a summary of the planning applications.

Alison Milton asked if there were any proposals to provide bins to recycle garden waste; this was dealt with by Cllr Laughton who stated that Newark & Sherwood DC proposed to introduce a third bin for compost in 2008.

It was noted that the first full recycling site was still 3 years away from completion.

Until this was available all electrical/electronic material should be taken to the recycling centres for eventual disposal.

The meeting closed at 7.37pm.

Apologies were received and accepted from Cllr. GD Stafford.

The Chairman suspended Standing Orders at 7.37pm to permit Cllrs. Stewart and Laughton to discuss matters with the council.

Cllr Stewart gave an update regarding the application to Building Better Communities and stated that the application had been unsuccessful. He suggested that he may be able to provide some funding towards a notice board, up to £300.

Cllr Laughton commented on the previous question posed to him regarding plan re-submission. He also commented upon a meeting he had been to with Inspector Charlton who had informed him that it was the intention of the local police to create more formalised working relationships with communities, working patterns had been changed with a view to better cover and allowing for better consultation. In 2006-2007 it was anticipated that more PCSO officers would be available to police the Farnsfield/Bilsthorpe areas.

Comment was made regarding the visits to Farnsfield by the Police Community Vehicle; normally parked in the Plough car park; it was considered that this was out of the way and the vehicle should be in the centre of the village. Cllr Laughton agreed to raise this matter with the police.

Cllr Laughton confirmed that Traffic Regulation Orders were being de-criminalised and the responsibility for enforcement would be passed over to Newark & Sherwood District Council with effect from 1 April 2007.

An update was provided after a recent CCTV inspection of the sewers on Branston Avenue had revealed no pipe defects.

Standing Orders were resumed at 7.52pm.

Declaration of interest

Cllr Bradbury declared that he was a member of the Rainworth Parish Council Village Centre Committee as a matter of information to be considered in the event of any conflict of interest occurring when Farnsfield Village Centre matters were discussed..

Recreation Grounds

- 1. Memorial Recreation Ground** – Cllr Peet commented that an area of moss was present on some tiles and required removal. Cllr Rhodes commented that no action had been taken to extend the dropped kerb at the entrance to the Tennis/Bowls Club.
- 2. Acres** – Comment was made that the shelter, built in the trees, had been burned down and some litter remained plus damage to some trees. The Clerk stated that he had received an expression of interest from Southwell United Youth teams to play matches on the Acres. It was agreed that this should be encouraged but a review of the charges for hiring the pitches should be undertaken. Comment was also made regarding any maintenance of the football pitch likely to be undertaken in the summer period.

3. **Wilson's Field** – The Clerk informed the meeting that Abacus had visited the hard play area to check out the lights following the complaint from Mr Fowler and their proposals were awaited. There was a view that this was an isolated complaint and did not warrant the level of attention it was receiving.
4. **Southwell Road** – No matters raised.

Cllr Elliott commented that the repeated concerns regarding parking in Farnsfield. Whilst raised with the Co. Cllrs. Had not been included in the minutes.

The minutes of the meeting of 9th May 2006 (planning) were proposed for acceptance by Cllr Jepson, seconded by Cllr Slight and accepted.

Election of Chairman

Cllr Slight took over as Chair of the meeting and requested nominations for Chair. Cllr Elliott proposed that Cllr Peet continue, seconded by Cllr Davis. There ere no other nominations; Cllr Peet was unanimously as Chairman for the following year, and resumed the Chair

Election of Vice Chair

Cllr Bradbury proposed that Cllr Slight should continue, seconded by Cllr. Elliott; supported with 1 abstention.

Election of Committee members

Cllr Bradbury proposed that the committee members be appointed en bloc in accordance with the existing committee membership; seconded by Cllr Jepson and agreed unanimously.

The Chairman suspended Standing Orders at 7.40pm to allow Co Cllr Stewart to provide an update to the Council.

Cllr Stewart provided an update following the meeting with the Chairman, The Clerk and Jo Horton (Notts. CC).

The matter of signs on Tippings Lane was discussed and it was the general feeling of the meeting that more was needed to slow down the traffic using Tippings Lane and the signs indicating restricted traffic flows were the desired option.

Comment was made regarding the large potholes appearing in the roads, particularly on New Hill, near to the tennis courts; grass on the footpaths on Parfitt Drive and flooding at the White Post roundabout.

Cllrs Bradbury and Elliott pointed out their concerns regarding the potential danger to pedestrians from the sloping footpaths on Station Lane and Quaker Lane.

Cllr Stewart agreed to inform the relevant officers.

Standing Orders were re-instated at 8pm.

- 1. Memorial Recreation Ground-** The Clerk reported that safety inspections had been carried out and some remedial was required as detailed in the report. This work will be completed by Sid Paver. No other issues to report.
- 2. The Acres –** An update was provided regarding the interest expressed by Southwell United to train youth teams on the

football pitched in the 2006-7 season. The maintenance of the field is currently under discussion with Notts. CC.

- 3. Parfitt Drive** – The Clerk reported that an inspection had been undertaken of the play equipment revealing two minor faults currently being rectified by Sid Paver. The quotation to provide 20 metres of knee high fencing at the perimeter of the car park at a cost of £350 was considered and approved. The quote to replace the shrubs in several areas was considered excessive and it was suggested that these areas be grassed over at less cost and less future maintenance.
- 4. Wilson's Field** – The Clerk reported that the area had been inspected and some minor faults had been identified and were to be rectified by Sid Paver. The quote to plant shrubs in the corner area was considered excessive and an alternative solution to be sought. The Clerk reported that he had received a letter from the Cricket Club requesting parking on Wilson's Field on Friday evenings. It was considered too dangerous to allow parking when a large number of children play in the area following the cricket training sessions.

Village Centre

The Clerk stated that he had received details of the CCTV equipment proposed for the Village Centre by Gill and Taylor. He also outlined a proposal from Globewatch to install infra red cameras supported by a computerised system on a lease basis; providing full maintenance, fixed price agreements for 7 years and replacement of equipment after 3 years for a weekly sum of £33.50p plus VAT.

It was proposed by Cllr Jepson that the equipment should be leased from Globewatch, seconded by Cllr. Davis and agreed.

The Clerk suggested that the £5000 donated by the late Irene Yates should be used to re-furbish the scout room during the summer holidays in August when the room would not be required. This was agreed and the Clerk was to prepare a specification and invite builders to submit a price with the proviso that the work can be completed during August 2006.

Co Cllr Stewart stated that he wished to comment upon 3 issues; Tippings Lane, Youth Service and White Post Roundabout.

Tippings Lane – Cllr. Jepson stated that he had met with Roy Potter to discuss the possibility of increased signage on Tippings Lane to indicate priority direction of travel. He stated that there had been three safety audits and none supported the proposal to install a traffic priority scheme.

After some discussion it was agreed that the Parish Council were desirous of the installation of the scheme and requested further support from Co Cllr Stewart.

Cllr Jepson informed the meeting that he had provided Notts. County Council with photographs of the surface puddling on Tippings Lane.

Youth Service – Co Cllr Stewart stated that the Youth Service would not be operating the Youth Club at Farnsfield for the time being.

White Post Roundabout – Cllr. Stewart said that the roundabout had been tidied up for the second time and NCC Highways would attempt to keep it in good order.

Co Cllr Laughton stated that there was to be consultation regarding Fiskerton Waste Disposal Unit. Bilsthorpe was not yet open, awaiting the licence to be issued.

Boundary proposal, Farnsfield Ward to have 3 Councillors, to be confirmed.

Police reorganisation is not proceeding.

Cllr. Jepson commented upon the general cleanliness of the roads and footpaths stating that there used to be a schedule of visits for street cleansing, and requested an updated copy.

The Clerk requested that Cllr Laughton make enquiries regarding the progress of the CCTV camera to be installed on Main Street by BT/Notts. CC.

Standing Orders were resumed at 7.55pm.

Cllr Stafford stated that he had been in contact with Notts. CC and they would not be hedge cutting until the end of July.

Comment was made regarding the state of the road surface on Station Lane. Details passed to Cllr. Stewart and Laughton to pursue.

Cllr Stewart informed the meeting that there could not be any arrangements for residents parking near to the Stackyard in the interim period whilst the responsibility for Traffic Regulation Orders was being transferred to Local Authorities.

Cllr Rhodes commented upon the recent problems experienced when storm water caused the sewers to overflow on the Green. He also commented regarding the drainage and surface of Tippings Lane. Cllr Stewart stated that a further meeting was being arranged with County Council Officers.

The proposed wind farm at Rainworth was discussed and it was agreed that much additional consultation was required.

The future of Fiskerton waste disposal unit and the proposed incineration unit were discussed. It was urged that the public should

be encouraged to complete the questionnaire regarding Fiskerton and sent it to Co Cllr Smedley.

Cllr Laughton commented upon the proposal to remove denominational transport to schools in 2007.

Cllr Jepson raised the matter of restoring regular street cleaning.

Standing Orders were resumed at 7.58pm.

The Chairman read out a letter he had received from Cllr Slight giving notice of his resignation effective from receipt of the letter, Friday 22nd July 2006. The reason given being that after giving his professional advice regarding VAT and the accounts for 2005-6 and this was not acted upon he felt his presence on the council was untenable. The Chairman stated that he had accepted the resignation on behalf of the Council.

He suggested that a Vice Chairman be appointed but this was deferred until 8th August 2006.

He reminded the meeting that during the past 10 years Farnsfield Parish Council had only increased its precept by 19% against a national average increase of 92%. He stated that the F&GP Committee recommended that the precept be set at £55,000 for 2007-8, a rise of £5000 due mainly to increases in charges for services provided to the Parish Council. He also explained that following the 'out of court' settlement agreed with the previous Clerk any rises in the precept had been absorbed from this money and the reserve funds; this situation could no longer be sustained. Cllr Jepson proposed that the precept for 2007-8 be set at £55,000, seconded by Cllr Davis and agreed unanimously.
- 3. Replacement of copying machine** – Cllr Jepson reported that the F&GP Committee had considered a request to replace the existing copying machine with a more up to date model, which would be faster, and cost approximately the same as the current one. It was agreed that the copier be replaced and the best financial deal be arranged.

After some discussion it was considered that whilst some improvements were required for the disabled to access the premises, most were internal. It was considered that the main external access should be from the existing entrance on the car park as any proposals to access from the front would add to the existing difficult traffic problems on Main Street. It was noted that there was a proposal to remove bollards at the front of the public house; this was opposed as unnecessary as there was adequate access from the rear; additionally the Parish Council, in conjunction with Notts. CC Highways had approved the existing street bollards in an attempt to reduce pavement parking and improve pedestrian safety. It was proposed by Cllr Elliott that the application be rejected on highway grounds and alterations to the front of the public house not being in keeping with the conservation area. Seconded by Cllr Jepson and agreed.

It was also proposed that Phil Ford be employed to conduct this work at a cost of £3000 per annum.

Cllr Clarke proposed that the Parish Council take over the ground maintenance, employ Mr Ford and purchase the equipment. Seconded by Cllr Davis and agreed unanimously.

It was agreed that the Clerk get the best price for the equipment and agree purchase following consultation with the Chairman and Vice Chairman.

Accounts

The Clerk presented a schedule of accounts containing 7 cheques amounting to £2791.73p, scrutinised by Cllr Peet. They were proposed for approval by Cllr. Clarke, seconded by Cllr. Reynolds and approved.

The Chairman suspended Standing Orders at 7.32pm to allow open discussion.

Cllr. Stewart informed the meeting that he had made enquiries regarding a 30mph speed limit on Cockett Lane, it appears that this cannot be progressed until the 2008 reviews take place.

Cllr Laughton informed the meeting of a County Council proposal to increase the costs of home care to the elderly to enable them to keep the rise in council tax to 4% for 2007-8.

A general discussion covered the meeting with Bob Hart, Director for Highways, Notts County Council. The information from Bob Hart to arrange for slow signs to be painted on the road surface of Tippings Lane and a safety review of Station Lane/Cockett Lane.

Policing was discussed and Cllr Laughton commented that additional Community Safety Officers would be recruited in 2007.

Cllr Elliott commented that the road surface on Main Street was unsafe for horse riders in wet and icy conditions. Cllr Stewart stated that the quality of surfacing used was standard throughout the county with anti skid treatment installed at junctions and other areas in accordance with EEC guidelines.

The Clerk informed the meeting that he had been in contact with Newark 7 Sherwood District Council regarding the S 106 grant of approximately £13,500 to be paid by the developers of the Main Street school site.

Cllr Peet informed the meeting that the old school field was being prepared for use as a car park for the building site workers.

Cllr Elliott stated that there was an opportunity to apply for funding from WREN and the National Sports Fund for the project on the Memorial Recreation Ground, Bowls/Tennis/ Multi Gym Project. This would be match funded from the S106 money and the application was required to be submitted by 5th April 2007; an urgent meeting of the working group is to be called involving the Tennis and Bowls groups.

Crime and vandalism

The Chairman provided a resume of the damage caused at Parfitt Drive; litter from broken bottles and polystyrene.

Cllr Stafford commented that a knife had been found by the grounds man ; damage had been caused to the guttering at the pavilion on the Acres ; the grit bin on Cocketts Lane had been overturned and there had been a fire near a seat on the Acres.

Cllr Peet stated that he and Cllr Jepson had met with the local Police Sergeant at Southwell and had discussed the recent spate of incidents with him; they were advised that the Council could not report incidents on behalf of third parties.

A general discussion then took place involving police presence, CCTV cameras.

Cllr Farr suggested that she contact Rippon Homes. The developers of the school site in order to arrange joint action regarding security in the centre of the village, this was approved.

He detailed the police staff at his disposal to cover several villages and confirmed that at that time Farnsfield did not have a beat manager, but one was due in March 2007. He also explained that the beat manager would also have responsibility for other villages and would be expected to respond to calls for assistance when on duty.

It was agreed that the availability to patrol in Farnsfield would be limited. He did state that Community Support Officers were being recruited and after training should be available in June 2007 when it was expected that Farnsfield should receive some attention.

Cllr Peet informed the meeting that he and Cllr Jepson had met with Sgt Hunt at Southwell Police Station and had discussed the recent spate of incidents with him, particularly in relation the elderly failing to call the police for fear of retribution, vandalism and general nuisance

issues. Concerns were expressed over the lack of response following reports to the police, other than via 999 calls; examples were given by members of the public present of a total lack of response to calls made to the police. It was considered that any calls over the main switchboard 0115 9670999 (and its variations locally) were a waste of time as they did not receive any response.

Examples were given of police being present at number at public meetings where no trouble was anticipated and a total lack of police presence in villages experiencing problems.

Inspector Gann was asked what was happening regarding the under age drinking in public places at Farnsfield; he was unaware of any fixed penalty tickets being issued in Farnsfield although there are provisions in place for this to take place.

It was agreed that a village approach was required and Cllr Armstrong agreed to assist by providing details of the relevant people, at District level, who could be of assistance to the village to address local problems.
